## ANNOUNCEMENT

The Board is pleased to announce that on 3 September 2009, Artist Empire, a wholly-owned subsidiary of the Company, entered into the Licence Agreement with Mattel Europa and Mattel, pursuant to which Mattel Europa agreed to grant Artist Empire a non-exclusive licence and right to use certain intellectual property rights of Mattel Europa, including (i) the mark "BARBIE" and related logos and images; (ii) "Nostalgic/Adult Barbie" and related trademarks and names; and (iii) "Barbie 50th Anniversary" and related trademarks and names, on certain fashion jewellery, home, computer and bath accessories produced by the Company as specified in the Licence Agreement to be distributed in the PRC, Hong Kong and Macao with effect from 1 May 2009.

The transactions contemplated under the Licence Agreement do not constitute a discloseable transaction nor connected transaction of the Company under the Listing Rules. This announcement is made on a voluntary basis to provide Shareholders with information of the Company.

## LICENCE AGREEMENT

The Board is pleased to announce that on 3 September 2009, Artist Empire, a wholly-owned subsidiary of the Company, entered into the Licence Agreement with Mattel Europa and Mattel, pursuant to which Mattel Europa agreed to grant Artist Empire a non-exclusive licence and right to use certain intellectual property rights of Mattel Europa, including (i) the mark "Barbie" and related logos and images; (ii) "Nostalgic/Adult Barbie" and related trademarks and names; and (iii) "Barbie 50th Anniversary" and related trademarks and names (together, the "Barbie Trademarks, Logos and Names"), on certain fashion jewellery, home, computer and bath accessories produced by the Company as specified in the Licence Agreement to be distributed in the PRC, Hong Kong and Macao with effect from 1 May 2009.

The Licence Agreement shall be for a term commencing from 1 May 2009 and expiring on 31 December 2012.

## **REASONS FOR ENTERING INTO THE LICENCE AGREEMENT**

As a result of entering into the Licence Agreement, the Company will be able to produce products bearing the Barbie Trademarks, Logos and Names which are internationally recognised. The Company believes that it will create a positive effect on the Group's corporate image and sales volume.

The transactions contemplated under the Licence Agreement do not constitute discloseable transactions nor connected transaction of the Company under the Listing Rules. This announcement is made on a voluntary basis to provide Shareholders with information of the Company.
