INTRODUCTION

Reference is made to announcement of the Company dated 13 April 2016 (“**Announcement**”) in relation to, among the other things, the Acquisition, the Subscription and the Whitewash Waiver and the announcements of the Company dated 4 May 2016 and 25 May 2016 in relation to the delay in dispatch of the circular (the “**Delay in Dispatch Announcements**”). Unless otherwise stated, capitalized terms used herein shall bear the same meaning as defined in the Announcement.

DELAY IN DISPATCH OF CIRCULAR

As set out in the Announcement and the Delay in Dispatch Announcements, a circular (“**Circular**”) containing, among other things, (i) further details of the Acquisition Agreement, the Subscription Agreement and the Whitewash Waiver; (ii) a letter of recommendation from the Independent Board Committee to the Independent Shareholders in respect of the Acquisition Agreement and the transactions contemplated thereunder, the Subscription Agreement and the transactions contemplated thereunder as well as the Whitewash Waiver and as to voting at the SGM; (iii) a letter of advice from the Independent Financial Adviser to the Independent Board Committee and the Independent Shareholders in relation to the Acquisition Agreement and the transactions contemplated thereunder, the Subscription Agreement and the transactions contemplated thereunder and the Whitewash Waiver; (iv) a notice of the SGM; and (v) other information as required under the Listing Rules and the Takeovers Code, for the purpose of the SGM, would be dispatched to the Shareholders of the Company on or before 15 June 2016.

As more time is required as originally envisaged to prepare and finalize the Circular, including but not limited to the additional information required under the Listing Rules to be disclosed in letter from the Independent Financial Adviser, accountants’ report of the Target Company and the pro forma financial information, the Company is unable to dispatch the Circular on or before 15 June 2016 as previously announced. As the Circular will incorporate the audited results of the Group for the year ended 31 March 2016, which in turn are expected to be announced by the Company on 28 June 2016, it is expected that the Circular will be dispatched to Shareholders after 28 June 2016, but not later than 30 June 2016, unless further extension is granted by the Executive.

An application has been made by the Company to the Executive for consent to the extension of time for the dispatch of the Circular on or before 30 June 2016 and the Executive has indicated that it is minded to such grant consent.

Shareholders and potential investors should be aware of and take note that the Acquisition and the Subscription, which are subject to a number of conditions precedent, may or may not proceed to completion. In particular, the Whitewash Waiver may not be granted by the Executive or approved by the Independent Shareholders. Shareholders and potential investors are reminded to exercise caution when dealing in the securities of the Company, and if they are in any doubt about their position, they should consult their professional advisers.
